**RESOLUTION TO SET TAX RATE**

**A RESOLUTION FIXING AND LEVYING SCHOOL DISTRICT AD VALOREM TAXES FOR THE MEMPHIS INDEPENDENT SCHOOL DISTRICT FOR THE YEAR OF 2021-2022, DIRECTING THE ASSESSMENT AND COLLECTION THEREOF:**

**Whereas**, the Board of Trustees of said Independent School District finds that the tax for the year 2021, hereinafter levied for all lawful expenses of the school district and the carrying out of the duties and responsibilities placed upon said school district by law must be levied to provide the revenue requirements of the budget for the ensuing year; and

**Whereas**, the Board of Trustees of said school district further finds that the taxes for the year 2021, herein shall provide the required sinking fund on outstanding bonds of the school district and on bonds proposed to be issued for such purposes; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MEMPHIS INDEPENDENT SCHOOL DISTRICT THAT;**

“THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR’S TAX RATE” and tax rate exceeds the no-new-revenue M&O rate

“THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.369 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$33.69

An ad valorem tax be set at the rate of \$0.96030 on One Hundred (\$100) Dollars valuation for the 2021 tax year, to be assessed and collected by the duly specified assessor and collector as follows:

\$0.96030 for the purpose of maintenance and operations; and  
\$0.00 for the purpose of payment of principal and interest on debts.
